Under the Government's draft Communications Data Bill, currently being assessed by Parliament, service providers will have to store details of internet use in the UK for a year to allow police and intelligence services to access it where appropriate.

Records will include details of the time, duration, originator and recipient of a communication and the location of the device from which it is made. It will include details of messages sent on social media, webmail, voice calls over the internet and gaming in addition to emails and phone calls. It does not include the content of messages.

Some people argue that law enforcement agencies need to keep up with the changing technology used by offenders and the Bill can help tackle security threats in the public interest. Others however argue that such proposals require more transparency, create a 'snooper's charter' and increase state and police power.

The government estimates that the Bill, funded by public expenditure, would currently cost around £1.8 billion over 10 years from 2012 which includes the cost of reimbursing service providers 'for any costs of complying' with the legislation.
