Cluster bombs are weapons which are made up of multiple explosive bomblets which can spread across a large area. Some of the bomblets fail to detonate on impact but could still explode for a long time after. The production and trade of cluster bombs in the UK has been banned. However, some British banks invest (such as make loans to, offer banking services to, or hold shares) in companies that produce cluster bombs in countries which have not banned them. This practice is currently not prohibited by UK law.
